### FROM THE BOARD

Welcome to the 2024 annual report of the Lime Lake Association. We are an all-volunteer board guided in our role by our vision and mission statements. Annually, the Board adopts a work plan and aligns our budget to meet the plan's objectives. Our focus is on the protection of our water quality, monitoring for invasive species, and educating our community.

Led by our biologist in collaboration with the Leelanau Conservancy, and with the help of riparian volunteers, we conduct regular water samplings and continue our work toward eradication of the Yellow Flag Iris. We also do eDNA sampling for the destructive invasive Eurasian Watermilfoil. In addition, we continue to offer free greenbelt consultations. This is a premium free offering for our riparians to take advantage of. The great news is that our water quality is outstanding and we have made significant improvements on the "Whole Lake Best Management Practices" survey, moving from near the bottom to near the top (with room left for improvement)!

In addition to our science objectives, we continue to strive toward 100% association membership. After all, our work benefits 100% of our riparians. We are grateful to so many of you who volunteered hours and made financial contributions in 2024. We are a small association with a big responsibility to preserve and protect our lake for future generations. Please consider making your 2025 donation soon to help us continue our important work.

In 2024, our online presence continued to grow, with over 2,000 visits to our website and an exciting increase in membership! ## **GOALS, OBJECTIVES & FINDINGS**

#### SHORELINE PRESERVATION

Greenbelt creation is an essential and manageable way to provide shoreline protection from erosion, to allow filtration of rain run-off and to protect our water quality.

From a 2024 survey, we can report that since 2019, we have increased the percentage of greenbelts and natural shorelines by 12%. We are proud that 43% of Lime Lake riparian properties can now be designated as either greenbelt or natural shoreline.

This is a huge celebration point for our lake and we hope it will motivate you to sign up for a free consultation (a \$100 value) with our biologist, Kelsey. We hope to see all riparians making efforts toward protecting our shoreline.

#### **ERADICATE INVASIVE SPECIES**

Invasive species drastically impact ecosystems. Our goal is always early detection and rapid response plans.



Lime Lake has a good diversity of native water plants. While we are currently spared the invasive Eurasian Watermilfoil, we do have Yellow Flag Iris (YFI).

With The Leelanau Conservancy, we host YFI summer dig events at our preserves, and Kelsey coordinates spot digs along property owner shorelines. We'll call for volunteers in early June, and Kelsey can assist riparians with YFI removal. Register your email at LimeLake.org to receive YFI alerts for your shoreline.

#### Lime Lake eDNA Study:

The 2024 Lime Lake eDNA monitoring by Freshwater Solutions LLC confirmed no presence of invasive species in the lake, reinforcing its ecological health. Water samples were analyzed for Red Swamp Crayfish, Eurasian Watermilfoil, Quagga Mussel, and other invasive species, with no detections.



Additionally, our grab samples tested for key health indicators, including human fecal pollution (HF183), Enterococcus, Mycrocystin, and Anatoxin. No human fecal contamination or harmful toxins were found, ensuring safe recreational water conditions. Enterococcus levels remained within acceptable ranges, and Mycrocystin levels were well below harmful thresholds. Ongoing data collection, including water temperature, turbidity, and pH, continues to support long-term lake health monitoring.

## **2025 BUDGET PROJECTION**

We budget generously to meet all obligations, and with a \$15,000 annual budget, we need all riparians to contribute membership dollars. Membership year runs January through December.

#### **Volunteer Spotlight**



### It's all Connected: The Good Harbor Bay Watershed Protection Plan

The Good Harbor Bay Watershed Protection Plan is a comprehensive document that coordinates the efforts of various partners to protect water quality with those of other watershed-wide groups to achieve designated and desired goals. Our Good Harbor Bay Watershed is the only watershed in Leelanau County that **does not currently have the very invasive Eurasian Watermilfoil.** Keeping it that way is essential for the ecosystem and the water quality of Lime Lake. The Good Harbor Bay Watershed includes 29,020 acres of land intersecting with the jurisdictions of five Leelanau County townships. Water flow does not follow township lines. This is why watershed maps and plans are essential to stewardship.



#### **PAT'S PRESERVE**

A big win towards our watershed goals that impacts the health of Lime Lake is the establishment of Pat's Preserve, owned and managed by The Leelanau Conservancy. The preserve opened to the public in 2024 and protects the wetlands and stream corridors feeding Lime Lake. Teischner Preserve at the northeast end of Lime Lake is also a highly treasured ecosystem that protects our watershed.

#### WHAT IS A WATERSHED

Our mission is to protect our lake. but we must understand that water is always traveling. Our actions today impact the quality of water moving via Shetland Creek at our north into Little Traverse Lake (LTL). Decisions made by LTL riparians impact the water moving via Shalda Creek into Lake Michigan. The water entering Lime Lake at our south end originates in the forested uplands north of Maple City with quality impacted by decisions made in those areas. This is a watershed: An area of land that drains to a common point and includes groundwater springs, wetlands, and the lake itself. Lime Lake is part of the Good Harbor Bay (GHB) Watershed.



In 2015, together with Little Traverse Lake and The Leelanau Conservancy, we developed the GHB Watershed Protection Plan. Such plans are required of all the state's major watersheds by the Michigan Department of Environment, Great Lakes and Energy. The plan allows for grant funding from various sources, and helps us to remember that **everything is connected**.

#### VOLUNTEERS NEEDED TO MONITOR FOR EWM

Community based monitoring (CBM) for Eurasian Watermilfoil (EWM) presents a cost-effective method for having all eyes on the lake for this dangerous invasive. CBM provides comprehensive surveillance through continuous monitoring during the entire EWM growing season.

Our vision is to engage at least one CBM volunteer for every 1,000 ft of shoreline around Lime Lake (note: each volunteer would only survey their shoreline, not the entire 1,000 ft). This amounts to roughly 20 volunteers. Of course, "the more the merrier" and each additional volunteer adds another layer of surveillance confidence!

Each volunteer would have access to a short training YouTube video, an EWM identification sheet, and a volunteer surveillance log with instructions. **Please visit our website for more information and to sign on as a CBM volunteer!**
